History of Church Foundation

The Foundation of the Algona 1st United Methodist Church was officially established with approval of the Administrative Council on September 25, 1985. The following statement is from the By-Laws of the Foundation:" The purpose of the Foundation shall be to accept funds of property by gift, beguest or devise, which funds shall be segregated from all other funds of the church, and set aside in separate accounts, as a permanent endowment fund of investments, the principle of which shall accrue perpetually, except as otherwise herein provided, and the income from which shall be used as determined from time to time in accordance with these By-Laws."

Since the interception of the Foundation in 1985, the Foundation has distributed earnings over \$400,000 to assist the many projects and missions of the church.

One of the ongoing projects of the Foundation is the "Foundation 50 Year Club." This is a "club" of persons who have been a member of the UMC or one of the merged churches for 50 or more years. 

Building Endowment – Fund allows Trustees to complete maintenance, care and improvement projects within the general budget.

Scholarship Endowment – Scholarship Committee annually reviews applications from students pursuing advanced education. Checks are awarded prior to attendance at the school of student's choice.

Missions Endowment – Fund allows Missions Committee to support special projects locally and beyond the Algona First United Methodist Church community. Gifts are channeled through Conference worldwide missions network.

Library Endowment - Fund is used to purchase books or other media for our church library.

Camping Endowment - Fund provides support for individuals attending church camping programs.
